Please find the response from Waikato DHB below in relation to your request received.

This request under the Official Information Act is in relation to Waikato District Health Board (WDHB) statistics and information for radiotherapy treatment, specifically in the 12-month period to 30 September 2019:

1) How many individual patients were treated at the WDHB with radiotherapy for cancer?

Waikato DHB provided external beam radiation therapy to 1422 patients during this period

2) How many individual radiotherapy treatments were provided to these cancer patients by the WDHB?

Waikato DHB provided 21470 individual external beam radiation therapy treatments to these patients during this period.

3) How many patients were referred to the WDHB to receive radiotherapy treatment?

Waikato DHB received 1593 radiotherapy patient referrals during this period. Note: 1647 referrals for the first specialist appointment (FSA) were received between January and December 2019. Some patients have more than one referral during the specified time period.

4) How many patients referred to the WDHB to receive radiotherapy treatment waited four weeks or more to start their radiation treatment from decision to treat?

a) Classified as a Category D patient (combined chemotherapy and radiation treatment as per treatment protocol)

Questions 4-11 figures exclude the 109 patients whose treatment was delayed due to

- a. patient choice
- b. clinical considerations (e.g. post-surgery wound healing)
- c. other management (e.g. brachytherapy before external beam radiation therapy)
- d. extraordinary circumstances (e.g. transport issue on way to treatment)
- 12) How many patients referred to the WDHB, who went on to receive radiotherapy treatment, received their first specialist consultation within four weeks?
- 13) How many patients referred to the WDHB, who went on to receive radiotherapy treatment, waited four weeks or more to receive their first specialist consultation?
- 14) How many patients referred to the WDHB, who went on to receive radiotherapy treatment, waited six weeks or more to receive their first specialist consultation?

15) How many patients referred to the WDHB, who went on to receive radiotherapy treatment, waited eight weeks or more to receive their first specialist consultation?

The radiotherapy first scheduled appointment occurs after the patient has finished their chemotherapy which is approximately 3 months after the referral was received.	65
